The 2021 calendar project is now underway, and we urge you to consider participating. Visitors to the Delaware and Raritan Canal experience beautiful views at every turn of the towpath. The Canal Watch invites you to photograph the scenic beauty of our historic waterway and send your photo(s) to us for possible inclusion in our 2021 calendar.

The canal has many places that, when captured in a photo, may encourage others to get out and explore the park by foot, bike, canoe, or kayak.

Photos will be judged by professional photographers and twelve images will be selected for the pages of the calendar.

# Entry rules for the photography contest will be as follows:

- Entries must be received by **June 30**, **2020**. The Canal Watch will submit them to the judges in July.
- Only amateur photographers may submit images to the contest.
- Photos must be sharp and in focus.
- Calendar print size is 12"x12". Original images may be submitted in landscape or portrait orientation but will be cropped square when in print.
- Photo files must be submitted in one of the following formats: jpg., tif., or eps. format, and in sRGB color space.
- Digital photo files must have the following properties: 300 dpi and 3,000 pixels on the longest side.
- Mobile phone files may be sent; however, they must be submitted at their highest resolution. Because the final reproduction size of the calendar is 12"x12", certain mobile files may be disqualified if they are not of the highest quality.
- Printed images will not be considered, nor will they be returned.
- Qualified images should be attached and emailed to <u>barthlinda123@aol.com</u>. You will be notified only if your image(s) are selected for inclusion in the calendar.
- Each photo must be clearly identified as to the location from which it was taken and the date taken. Photos can be submitted from <u>any year and showing any season</u>.
- The email must contain the photographer's name, address, phone number, and email address.
- By submitting your image(s), you agree to grant the D&R Canal Watch, a 501(c)(3) organization, the right to reproduce the photo(s) for calendar use in 2021. The D&R Canal Watch reserves the right to use the contest photo entries with entrant's name on the Canal Watch website, <u>www.canalwatch.org</u>, in print, and in promotional materials.

The Canal Watch has asked our partner organizations to contribute toward the \$5100 cost of creating a conditions assessment for the East Millstone bridgetender's station, which is the small structure next to the bridgetender's home. Our partner groups, the East Millstone Historical Society, the Canal Society of New Jersey, and the Millstone Valley Preservation Coalition, have all agreed to contribute toward this project. We will keep you informed about the next steps in this restoration process.



The D&R Canal Watch is asking for your support for our activities that protect, maintain, and promote the recreational, historical, aesthetic, and environmental qualities of the Delaware & Raritan Canal State Park. Over the past years, the Canal Watch has:

- Led history walks along both the main canal and the feeder, pointing out historic structures
- Led history bike rides along the main canal
- Sponsored bird watching walks along the main canal

• Sponsored lectures on topics such as "The Role of the Delaware and Raritan Canal in the Growth of Trenton's Industrial Potteries," "The Operation of the Joint Companies and the Interrelationship of the canal with the state's first railroad," "The Roebling Story," "Photography Along the Delaware and Raritan Canal State Park: Treasure in Central New Jersey," "Meet Ashbel Welch, the second chief engineer of the Delaware and Raritan Canal," and Jim Amon on how the canal and the park changed during his tenure with the commission.

• Purchased gifts that the park budget could not provide. These include a digital camera, seven picnic tables, several benches, a laptop computer and software, a desktop computer, an LED projector, an inflatable screen for outdoor viewing of videos, a subscription to the Meetup website, a scanner, printer ink, a water testing kit, an external computer drive, lumber for canoe dock at Griggstown, folding tables and twenty chairs for Bulls Island, development of a new park website, and courses for the maintenance staff.

• Canal interpretive signage at locks and spillways

• Activities in 2009 marking the 175<sup>th</sup> anniversary of the opening of the Delaware and Raritan Canal. These included "Meet the Canal Authors Day" and "The D&R Canal: Yesterday, Today, Tomorrow," by Richard Hunter" walks, bike rides, canoe and kayak rides, "Hands Along the Canal," and proclamations from our legislature.

- Examination of Lock 9 to determine the feasibility of reopening the lock to navigation
- Post-flood cleaning of canal structures in Griggstown, Zarephath, and East Millstone
- Painting over graffiti in East Millstone
- Repair of shutters on the East Millstone bridgetender's home
- Straightening and painting of the outhouse at the East Millstone bridgetender's home
- Staffing the East Millstone bridgetender's home during the village's Canalfest in October
- A photographic exhibit of the homes of bridgetenders and locktenders.
- Services of an information technology consultant for the park's computers
- Funded classes to certify maintenance staff in small motor repair, applying herbicides, etc.
- Contacted legislators and the governor's office to keep the parks open and retain the commission
- Facilitated the mothballing of an empty bridgetender's home by buying lumber and painting the windows.
- Installed Kaya-Arms on docks to facilitate entering and exiting kayaks

<u>Sunday, August 9</u>: 10:00-4:00. Canal Road Walk and Roll. Canal Road closed from Griggstown Causeway to Route 518 in Rocky Hill. Enjoy a day along the scenic D&R Canal with no cars!

The Canal Road closings are likely to be cancelled, but that decision was not made before we went to press. Sunday, August 30: Canal Road Walk and Roll. 10:00-4:00. Canal Road closed from East Millstone to Butler Road. Enjoy a day with friends and family along the scenic D&R Canal with no cars!

Saturday, September 12: 9:15 a.m. Light Rail Trip, Bordentown to Trenton and back. Join Pamela V'Combe for a tour by light rail into the 19th century. MP Meet at the Bordentown River Line light rail station at 9:15 a.m. (Turn left into parking lot at 100 W. Park Street at Prince Street, above the boat landing.) Purchase your tickets and receive a brief introduction before boarding the train for Trenton. The train follows the D&R Canal path from Crosswicks Creek to Trenton. See the abandoned canal, Watson's Creek, and the Abbott Marshlands. In the City of Trenton where Route 129 is on the former route of the canal, remains of the industrial and commercial buildings can be compared with earlier photos. Participants will get an overview of places that are difficult to see any other way, but on the train. In Trenton, participants may opt for a guided walk (¾-mile round trip) to the State Street Bridge over the former canal (now the Trenton Freeway). The Canal Watch is sponsoring an astronomy star gaze on November 6, 2020 from 7-11p.m. This year will be an excellent opportunity to view the planets. Saturn with its magnificent rings and giant Jupiter will be sinking in the southwest during the early part of the evening. The red planet Mars' close approach to the Earth this season will make it optimally placed for viewing and the distant gaseous planets Uranus and Neptune will be visible in the constellations Aries and Aquarius. Overhead we will look at the many star clusters and nebulae in the summer Milky Way. Later in the evening the Moon will rise in the east, displaying its distinctive craters and mountains. Below is an invoice from September 19, 187\_. It was issued by the Citizens' Line Steamboats, which operated between New York and Troy. The invoice indicates that the Liberty Corner Presbyterian Church in Somerset County was charged \$322 for the transportation of the church bell from Troy. It is likely that the steamboat carrying the bell came down the Hudson River and then took the D&R Canal to Bound Brook. From there, the bell was carried by horse and wagon up the Watchung Mountains to Liberty Corner. — Submitted by Gayle Canary, Martinsville, New Jersey

The bell was probably manufactured at the Jones foundry, which was started in 1852 by James Harvey Hitchcock and Eber Jones, in the industrial city of Troy, on the eastern bank of the Hudson River. James Hitchcock had previously worked in Andrew Meneely's bell foundry in West Troy, NY, on the western bank of the Hudson River. Hitchcock was related by both descent and marriage to the Meneely family, and at the time of Andrew Meneely's death in 1851, he was foreman of that bell foundry. James Hitchcock retired from the business in 1857, after which the name of the firm was changed to "Jones and Company, The Troy Bell Foundry."

# The Gas Pipeline and the Compressor Have Been Stopped

Did you hear the BIG news? In separate decisions late on Friday, May 15, the New Jersey Department of Environmental Protection and the New York State Department of Environmental Conservation both denied key permits for the Northeast Supply Enhancement (NESE) project, a proposed 23-mile-long natural gas pipeline on the bottom of Raritan Bay and compressor station in Franklin Township.

On top of that, the company cannot reapply again—which means the project is stopped FOR GOOD! Thousands of community members, elected officials, and local environmental groups spoke up and worked together for years to stop this project.

We are so proud of all the hard work we put in with dozens of allies to stop this project that would have created dangerous air pollution and emissions that could hurt New Jersey families. It's a huge blow not only to Williams Transco, but to all big polluters and the lawmakers they've bought off across the country.

We are also grateful for Governor Murphy and New Jersey DEP Commissioner McCabe's environmental leadership. Even in the face of pressure from major corporations, Governor Murphy has demonstrated his commitment to our 100 percent clean energy future by rejecting projects that are not needed and could derail efforts for a decarbonized New Jersey.

Good things can happen when you work hard and stick to what you know is right. It's through the power of people that we will continue to stop more fossil fuel projects like this one across the country. Thank you for being a part of this fight.

## Here is what people have been opposed to for many years.

#### Stop the Williams-Transco Gas Pipeline & Compressor Station

• The Williams/Transco pipeline is carrying *fracked* gas from the Marcellus Shale in Pennsylvania across Mercer, Somerset and Middlesex Counties into the Raritan Bay to New York. The added pipeline will cut through Old Bridge and Sayreville. *None of* this product is for use by NJ residents.

• The process of fracking injects toxic chemicals into the earth, pollutes precious water no longer available for drinking and bathing, destroys farmland, contaminates the environment, and causes earthquakes and tremors. It also intensifies global warming and climate change.

• A new gas-powered compressor station is being planned at the site by Trap Rock Quarry, near the Delaware and Raritan Canal in Franklin bordering on South Brunswick, where active dynamite blasting occurs. Compressor stations pressurize the gas, which will risk leaking toxic gases like methane and benzene into the air and groundwater. Methane will worsen global warming.

• The pipeline will run into and under the Raritan Bay, which will jeopardize the ecology of coastal and marine life, and threaten the livelihood of those who depend on healthy and safe seafood.

• The danger of fires, explosions, and serious injuries from leaks and ruptures is a real threat and has already occurred in Edison and Branchburg, NJ.

• The future lies in renewable sources of energy that do not threaten our health and safety, our environment, and our ability to survive on this planet.
