
As usual, we have included a map and a history of the D&R Canal.

## **Canal Coalition Saved the Waterway**

In 1984, for the 150th anniversary of the opening of the canal, the Packet Publications printed an eight-page insert with many stories of our historic waterway. Below, we include one article about the work of the D&R Canal Coalition.

It could be said, without too much exaggeration, that the Delaware and Raritan Canal Coalition saved the canal.

Back in 1973, the canal was everybody's kicking boy, exploited, abused, allowed to deteriorate. It faced being cut up, piped, and paved over.

But a group of citizens, spurred by the plans of Trap Rock Industries to build a road along the canal bank between Rocky Hill and Kingston, decided to fight for the canal. That fight finally ended in 1974 with the passage of a remarkable piece of state legislation that created the canal state park and a canal commission with unusual powers to control development and drainage, even outside the boundaries of the park.

### Help us celebrate the 50th Anniversary of the D&R Canal State Park and the D&R Canal Commission in 2024

In 1974, most of the Delaware and Raritan Canal was declared a New Jersey state park, which, is used for canoeing, kayaking, cycling, fishing, horseback riding, birding, walking, jogging, and enjoying nature..

<u>P.L. 1974. C 118</u> -- The "Delaware and Raritan Canal State Park Law of 1974" designated the lands along the canal owned by the State of New Jersey as the Delaware and Raritan Canal State Park. The legislation also created the Delaware and Raritan Canal Commission, set forth the Commission's powers, functions and duties, established the boundaries of the Commission "Review Zone." The legislation also created the present

D&R Canal Commission land use regulatory program. This concurrent resolution established a special legislative commission to study and develop a plan to protect, preserve and maintain the Delaware and Raritan Canal.

The D&R Canal Watch, a friends group that works with the state park staff, is planning a speaker series, a new book of canal poetry, and a collectible mug for the 2024 celebratory year. A graded natural-surface trail along the side of the canal, which was the towpath on which mules used to tow canalboats, is now used for recreation. A series of loop trails, using bridges that cross the Delaware River, connect the D&R with the towpath in Pennsylvania's Delaware Canal State Park. About 36 miles of the main canal, and all 22 miles of the feeder canal, are still used. The park is operated and maintained by the New Jersey Division of Parks and Forestry.

The canal is accessible from many points along its route, with small parking areas providing access at most road crossings. Check the official state park website, <u>www.dandrcanal.com</u>, for a map and access points.

#### News from the D&R Canal Commission meeting, September 20, 2023

#### Executive Director's Report

Director Hutchison stated that although the modestly improved fee collections were a relief, the Commission staff would need to remain vigilant with respect to spending until fee revenues come into line with the anticipated appropriation amount. This issue, along with other fiscal matters, will be discussed at the Fiscal Year 2024 quarterly budget meeting which, he stated, would include the DEP Comptroller Stephen Matis and Natural and Historic Resources Operations Chief Madden.

The Director reminded the Commissioners that he cancelled the Commission's purchase order with ACCSES-NJ for the Commission file scanning project. He noted that a large document scanner has been leased from Ricoh for 48 months at a cost of \$322.81/month and will be delivered to the office on September 28.

Director Hutchison reported that a number of Commissioners are not available to attend the November 15 Commission meeting, and the only day a quorum was present within a reasonable time period of that date was Wednesday, November 29. Therefore, staff would reschedule the November meeting for 10:00 a.m. on Wednesday, November 29, 2023.

He reported that Commission staff completed draft "Frequently Asked Questions" (FAQs) regarding the interaction between the new DEP Inland Flood Protection Rules and the Commission's rules. On the advice of the Office of the Attorney General, staff was waiting to post them to the Commission website, and that this would likely occur once the DEP issued its own guidance with respect to the regulations.

He reported that the third meeting of the New Jersey Department of Transportation (NJDOT) Route 29 Kingwood Rockfall Mitigation Project -- Design Working Group Meeting is scheduled for October 2. He hoped more will be learned about both the Kingwood and Lambertville/Goat Hill projects.

Director Hutchison reported that NJDOT reported several challenges to the Commission with respect to their project to replace the bridge that conveys Washington Road (Mercer County Route No. 571) over the Delaware and Raritan Canal in Princeton/West Windsor Township. These included an unaccounted-for concrete obstruction, which, after consultation with the project's archaeological team, was not significant. He stated that NJDOT also encountered issues with the depth of the existing bulkheads' timber planks, which are used to retain the embankment. Specifically, they terminate at a higher elevation than originally anticipated. As a result, excavating down behind these walls (outside of the canal) for the installation of the new timber façade could result in instabilities of the embankment. The contractor requested that the bottom of the timber façade be raised to reduce risk of destabilization. The contractor requested the façade be terminated 1.0 foot below the canal. The NJDOT proposes terminating the façade 1.5 feet below water at the west side of the canal, and 3.0 feet below water at the east side.

Finally, Director Hutchison reported that a sinkhole developed at Prallsville Mills at the rear of the historic grist mill. He stated that two raceways existed on the site in the 19th century that powered the grist and sawmills. One of these raceways, known as the "tail race," exits the grist mill, turns sharply toward the left and proceeds under the Wickecheoke Creek, the former rail trestle and ultimately to the Delaware River. He reported that Commission staff was alerted to the sinkhole by park patrons. The Commission notified the State Park Service, which in turn placed cones, barrels and tape to cordon off the area. The Commission also provided the Park Service and DEP Office of Resource Development (ORD) with copies of the 1986 Prallsville Master Plan so that those groups were aware of the location of the tail race. Director Hutchison stated that, on Friday, September 22, there would be a meeting with ORD to determine how best to conduct an emergency repair.

#### Park Superintendent's Report

Commissioner Designee Mark Texel stated that Superintendent Rojewski was unavailable to attend the meeting, and that he would provide her report. Mr, Texel reported that the Big Bear tubing concession has ceased operations in Kingwood Township for the season, and that the Fairview and Cooley Tract parking lots in Kingwood Township had been reopened for public use. He reported that Park Service seasonal staffing had been reduced, and that remaining park staff would continue to support park projects and administrative work, including the installation of signage at the Delaware River parking lot in Frenchtown. He also noted that the Borough had removed picnic tables from the river area, which he hoped would deter unauthorized swimming and general overuse.

Mr. Texel reported that a Delaware River cleanup event was held on September 16, coordinated by the Delaware River Greenway Partnership and park naturalist Stephanie Fox. More than 200 volunteers cleaned up

18 different locations from Frenchtown Borough south to Trenton. Commissioner Designee Texel stated that a sinkhole caused by a collapsed storm sewer pipe was reported in July by a homeowner who lives on Easton Avenue/Main Street in South Bound Brook, adjacent to Delaware and Raritan Canal State Park property. Following assessment of the site conducted by the NJWSA and the State Park Service, it was determined that the pipe in question was not State infrastructure. South Bound Brook Borough subsequently determined it was not municipal infrastructure, and it was likely that the pipe was a drainage feature installed by a property owner without the required permitting. Although not assuming ownership, the State Park Service with the help of NJDOT would commence repairs to the pipe as an emergency measure. He noted that an application to authorize the emergency project would be submitted to the Commission in due course.

Mr. Texel reported that on August 31 a helicopter taking off from Princeton Airport crashed in the Delaware and Raritan Canal State Park in the vicinity of Carnegie Lake and Route 27 in the Kingston area of South Brunswick Township. State Park Service staff and the State Park Police supported the response effort by implementing park access closures and by issuing public notifications. On September 2, 2023, access to the park was restored.

He reported that the Delaware and Raritan Canal State Park towpath would be closed from September 18 through September 22 in the area of Six Mile Run due to the ongoing NJWSA culvert repair project (See below)

#### New Jersey Water Supply Authority (NJWSA) Report

Mr. Michael Sellar reported that, in addition to the information Mr. Texel provided regarding the helicopter accident, he went to the scene and observed that a boom had been placed across the Millstone River as a precaution in the event that fuel or other fluids leaked from the aircraft; however, he detected no sheen on the water surface.

Mr. Sellar reported that work was completed, with the exception of some short "punch list" items, on the Landing Lane Spillway rehabilitation project in New Brunswick.

Michael informed the Commission that the project to rehabilitate the stone culvert, which conveys Six Mile Run underneath Canal Road, the Delaware and Raritan Canal, and the towpath in Franklin Township, Somerset County, was underway. The project will involve periodic road and towpath closures, which will be posted on the park website.

Mr. Sellar reported site work had commenced for Phase 1 of the project to repair an approximate 1.0-mile section of the western embankment of the Delaware and Raritan Feeder Canal in Stockton, which separates the canal from the Delaware River, and is generally located between the Prallsville Lock and the railroad bridge crossing over the canal at Brookville in Stockton. He stated that the tarps were removed, tree trimming, tree removal work and vegetation clearing had started, and some embankment repairs were started. The contractor anticipated an early December completion of the Phase 1 project.

Mr. Sellar reported that NJWSA continued to monitor the canal for the presence of the invasive aquatic plant hydrilla. He stated that no hydrilla plants were found during the 2023 season, and that a tuber survey would take place in October.

Mr. Sellar informed the Commission that the contractor for the project to replace 11 canal sluice gates located at four locks in Somerset County had placed the order for the gates and that significant time would be needed to manufacture the devices.

Mr. Sellar stated that NJWSA continued to monitor the Delaware and Raritan Canal and the Millstone River for a blue-green harmful algal bloom (HAB) caused by Cyanobacteria (i.e., Blue-green Algae), which was detected in the Millstone River last summer; however, no bloom had been detected thus far. Mr. Sellar stated that NJWSA staff was addressing the sinkhole associated with a culvert on Easton Avenue (Somerset County Route No. 514) in Franklin Township near the border of that municipality with South Bound Brook Borough. He stated that a repair design and a pre-bid site meeting was scheduled for September 21.

The D&RCC meets at 10:00 a.m. on the third Wednesday of each month. The public is allowed to comment on the proceedings. In-person meetings have resumed; they are held at Prallsville Mills on Route 29, just north of Stockton Borough. The coalition's efforts were one of those few truly rare success stories, so much so that its accomplishments pretty much put it out of business.

But in 1983 the coalition returned, and with a vengeance that brings back memories when it was the canal itself that was at stake. This time it was the region and the prospect of overriding development that disturbed the reborn coalition.

The coalition feared that the canal park could become a thin, green thread in a gray expanse of housing and buildings spread like a sheet across Central New Jersey.

The coalition took on a number of projects to extend the green space from the canal, including participation in the national Greenway effort.

Another major project begun was the restoration of the Muletenders barracks in Griggstown. The state leased the building at \$1 per year to the coalition.

The project, planned in cooperation with the Griggstown Historical Society, required \$30,000 in contributions and the coalition began a fundraising effort. The Geraldine R. Dodge Foundation promised a \$10,000 grant to the coalition for the establishment of an educational program on the canal, which was tied to local schools. Besides an information area, other parts of the building could be leased to civic or volunteer organizations.

Another effort that got underway was the "Level Walker" program. Level walkers were canal company employees who walked the towpath, looking for problems. Coalition Level Walkers were members who kept watch over assigned sections of the canal. The Level Walkers received patches and I.D. cards and mailed in periodic reports on their particular section.


#### UPCOMING EVENTS YOU MAY WISH TO ATTEND

- Post-flood cleaning of canal structures in Griggstown, Zarephath, and East Millstone

- Straightening and painting of the outhouse at the East Millstone bridgetender's home
- Staffing the East Millstone bridgetender's home during the village's Canalfest in October
- A photographic exhibit of the homes of bridgetenders and locktenders.
- Services of an information technology consultant for the park's computers
- Funded classes to certify maintenance staff in small motor repair, applying herbicides, etc.
- Contacted legislators and the governor's office to keep the parks open and retain the commission
- Facilitated the mothballing of an empty bridgetender's home by buying lumber and painting the windows.
- Installed Kaya-Arms on docks to facilitate entering and exiting kayaks
- Funding the park's website and continued updating
- Paying the dues for the Meetup site used for announcing park activities
- Sponsored lectures on topics such as "The Role of the Delaware and Raritan Canal in the Growth of Trenton's Industrial Potteries," "The Operation of the Joint Companies and the Interrelationship of the canal with the state's first railroad," "The Roebling Story," "Photography Along the Delaware and Raritan Canal

State Park: Treasure in Central New Jersey," "Meet Ashbel Welch, the second chief engineer of the Delaware and Raritan Canal," and Jim Amon on how the canal and the park changed during his tenure with the commission.

• Purchased gifts that the park budget could not provide. These include a digital camera, seven picnic tables, several benches, a laptop computer and software, a desktop computer, an LED projector, an inflatable screen for outdoor viewing of videos, a subscription to the Meetup website, a scanner, printer ink, a water testing kit, an external computer drive, lumber for canoe dock at Griggstown, folding tables and twenty chairs for Bulls Island, development of a new park website and maintenance of the site at the rate of \$50 per month, and professional courses for the maintenance staff.
