Fifty years ago this October, New Jersey Governor Brendan Byrne signed legislation to create the D&R Canal State Park, now a 70-mile linear park passing through four Central Jersey counties. To celebrate the 50<sup>th</sup> anniversary of the park and the D&R Canal Commission, the nonprofit D&R Canal Watch has announced a walk-run-bike event called **Tour de Towpath**, centered at Cadwalader Park in Trenton on Saturday, October 26. Registration is now open at <u>www.tourdetowpath.org</u>.

"The D&R Canal State Park is the second-most visited New Jersey State Park and one of the state's best outdoor recreation resources. The Tour de Towpath is the perfect way to increase awareness and celebrate the park and Canal Commission," said Linda Barth, president of D&R Canal Watch, a nonprofit group that organizes volunteer projects and raises funds for the park.

The Tour de Towpath will feature a flagship 50-mile bicycle ride to Colonial Park in Franklin Township, as well as a 20-mile cycling route to Princeton's Turning Basin Park; a non-competitive half-marathon run/walk to Washington Crossing State Park in Hopewell; and a 5k fun run/walk. A festival at the City of Trenton's Cadwalader Park will greet participants upon their return with music, food, and a community village featuring local nonprofits.

"As we celebrate the 50th anniversary of the D&R Canal State Park with the **Tour de Towpath** event, we honor not only the beauty and importance of the canal but also the dedication of the community and organizations that support it," said Trenton Mayor Reed Gusciora. "I encourage everyone to join us for a day of fitness, fun, and festivities as we come together to recognize this remarkable park and its impact on our region."

All registered volunteers and participants will receive an event T-shirt. To register or donate, visit the event website as <u>TourdeTowpath.org</u>. Registration is \$50 in advance and \$60 the morning of the event; volunteer registration is free.

The friends group in charge of each home welcomed visitors and provided a tour and history of the building.

Each visitor received a passport that was stamped at each house. Those who visited all five received a small prize.



Among the many comments heard were these:

When I got to Port Mercer, I was impressed that the team there was **young**—two teenage boys and a very pregnant young woman. It's a small house compared to East Millstone, but the last family occupying it really did have six children.

The young lady I talked with at Blackwells Mills was the granddaughter of the last bridge tender there - and he lived there, without electricity or running water, by his choice, till 1970.

From Port Mercer: We had 127 people visit, including children. We received quite a bit of positive feedback from visitors who really enjoyed the varied programs at each of the houses.

47 persons signed the log book; however, not everyone did – especially children. Also 6 persons signed who did not take the tour; two from Kingston – who just stopped by and a group of four "on holiday" from England – who when asked for their passports were uncomfortable until the challenge was explained, but then were delighted with the lock and bridge models and exhibits and asked many questions.

Most people were particularly interested in the demonstration of the lock and bridge models, but were also interested in general about the canal and how it functioned. Many asked questions and also commented favorably on our exhibits. Our cookies and cider were also a big hit.

Last, but not least, many commented most favorably on the concept of the Canal House Challenge. Some thought it should be repeated.

#### D&R Canal Commission and D&R Canal State Park Host Huge Celebration

On a beautiful Saturday in September, the state park and the commission held an all-day celebration for the 50th anniversary of both organizations.

Organized by Vicki Chirco and Pamela V'Combe, the morning session featured an invitation-only panel discussion and luncheon in the Prallsville Grist Mill. Vicki introduced Jane Rosenblatt-Birkhofer, DEP deputy commissioner, who reminisced about her early days as a park interpreter. Bruce Stout, vice-chairman of the canal commission, welcomed the attendees.

Four panelists with many years of experience working on the D&R discussed the successes and problems that they faced. Moderator John Hutchison, executive director of the commission, introduced

- Jim Amon, the commission's first executive director, 1975-2005;
- Marc Brooks, executive director of the New Jersey Water Supply Authority;
- Al Payne, administrator of DEP's Office of Resource Development; and
- Paul Stern, superintendent of the D&R Canal State Park, 1980-1998.

Afterward guests were treated to a delicious lunch catered by Lovin Oven Cakery from Frenchtown.

The afternoon featured all-day entertainment by The Successful Failures (right), a Trenton band that "combines

A crowd favorite was the 12-foot tall Smokey Bear, brought by the New Jersey Forest Fire Service.

# WHAT IS IT? Canal terms explained

**Spillway**—A spillway is a structure used to provide the controlled release of water downstream from a dam or levee, typically into the riverbed of the dammed river itself.

On a canal like the D&R, the spillway allows excess water to flow out of the canal, down the spillway, and into a nearby stream; this prevents the

canal water from overflowing and eroding the towpath. A spillway can also be described as a passage for surplus water to run over or around an obstruction (such as a dam).

According to NOAA\*, a spillway is a structure over or through which excess or flood flows are discharged. If the flow is controlled by gates, it is a controlled spillway, if the elevation of the spillway crest is the only control, it is an uncontrolled spillway.



A typical spillway (on left) along the D&R Canal. This spillway is part of the towpath and is made of stone to prevent the erosion of the towpath.

This spillway (on the right) controls the level of the Llangollen Canal in Wales.





This very large spillway takes excess water from Gatun Lake, a part of the Panama Canal. During the rainy season, the lake can easily overflow.


## World Canals Conference Returns to the USA in 2025

Two hundred years after the Erie Canal's grand opening, international inland waterways experts and enthusiasts will gather in Buffalo, NY, bringing that same transformative spirit of innovation to drive the next century of service for canals everywhere. From September 21-25, 2025, the World Canals Conference will return to the USA for the first time since 2021. Buffalo and the Erie Canal provide the backdrop this time around, where attendees will dig deep into how canals around the world are using new technologies, sustainability, tourism, and heritage development to address our shared challenges and thrive.

# The World Canals Conference is suitable not only for professional canal managers, but also for boaters and enthusiasts.

Buffalo is a shining example of canal reinvention. When the Erie Canal opened in 1825, Buffalo became a commercial and industrial powerhouse, only to see the canal's use wane in the mid-20th century and trigger a period of disuse and disrepair. Beginning in 2005, the Erie Canal Harbor Development Corporation successfully spearheaded an era of waterfront transformation and reclamation. Today, the revitalized Canalside area (see photo below) in downtown Buffalo bustles with new energy, business, and tourism. The city's famous grain elevators have been repurposed to host live performances, events, and historical tours. Buffalo is receiving recognition for its vibrant art scene, diverse dining, outstanding outdoor recreation, treasured architecture, and dramatically transformed Canalside waterfront.


Buffalo and the Erie Canal Bicentennial create an ideal setting and moment for the World Canals Conference 2025. Built around the theme of "Sustaining our Multidimensional Waterways," WCC 2025 will bring together the leading minds in diverse fields to discuss, debate, discover, and inspire. Attendees will partake in expertly guided field sessions, gain access to exclusive tours in the days leading up to or following the conference, and witness history repeating itself with the send-off ceremony for the replica canal boat *Seneca Chief.* This traditionally built, full-size replica of the same boat that opened the Erie Canal two hundred years ago departs Buffalo for New York City, replicating the 1825 journey that became known as the Wedding of the Waters.


The Buffalo Maritime Center has built a traditional, full-sized replica of the Erie Canal Boat *Seneca Chief*, which originally opened the Erie Canal in 1825. From the start, the Erie Canal Boat Project has aimed to engage the community through hands-on experiences and historical exploration. This community boatbuilding effort, made possible by hundreds of volunteers, took place inside the Longshed at Canalside on Buffalo's waterfront from October 2020 to June 2024.

In 2025, the *Seneca Chief* will embark on its Bicentennial Voyage from Buffalo to New York Harbor, commemorating Gov. DeWitt Clinton's 1825 inaugural journey. The D&R Canal Watch is asking for your support for our activities that protect, maintain, and promote the recreational, historical, aesthetic, and environmental qualities of the Delaware & Raritan Canal State Park. Over the past years, the Canal Watch has:

- Restored the Kingston canoe/kayak boat launch
- Paid for the <u>conditions assessment</u> and the <u>engineering drawings</u> for the East Millstone and Griggstown bridgetender stations.
- Working with the park, we posted signage at six locations to help visitors find their way through Trenton.
- Led history walks along both the main canal and the feeder, pointing out historic structures and Light Rail study tours
- Led history bike rides along the main canal.
- Sponsored star-gazing and solar observation events.
- Sponsored bird watching walks along the main canal and bilingual nature walks
- Installed and facilitated canal interpretive signage at locks and spillways

• Activities in 2009 marking the 175<sup>th</sup> anniversary of the opening of the Delaware and Raritan Canal. These included "Meet the Canal Authors Day" and "The D&R Canal: Yesterday, Today, Tomorrow," by Richard Hunter" walks, bike rides, canoe and kayak rides, "Hands Along the Canal," and proclamations from our legislature.

- Examination of Lock 9 to determine the feasibility of reopening the lock to navigation
- Post-flood cleaning of canal structures in Griggstown, Zarephath, and East Millstone
- Painting over graffiti in East Millstone
- Repair of shutters on the East Millstone bridgetender's home
- Straightening and painting of the outhouse at the East Millstone bridgetender's home
- Staffing the East Millstone bridgetender's home during the village's Canalfest in October
- A photographic exhibit of the homes of bridgetenders and locktenders.
- Services of an information technology consultant for the park's computers
- Funded classes to certify maintenance staff in small motor repair, applying herbicides, etc.
- Contacted legislators and the governor's office to keep the parks open and retain the commission
- Facilitated the mothballing of an empty bridgetender's home by buying lumber and painting the windows.
- Installed Kaya-Arms on docks to facilitate entering and exiting kayaks
- Funding the park's website and continued updating
- Paying the dues for the Meetup site used for announcing park activities

Canal Watch Achievements (continued)

- Sponsored lectures on topics such as "The Role of the Delaware and Raritan Canal in the Growth of Trenton's Industrial Potteries," "The Operation of the Joint Companies and the Interrelationship of the canal with the state's first railroad," "The Roebling Story," "Photography Along the Delaware and Raritan Canal State Park: Treasure in Central New Jersey," "Meet Ashbel Welch, the second chief engineer of the Delaware and Raritan Canal," and Jim Amon on how the canal and the park changed during his tenure with the commission.
- Purchased gifts that the park budget could not provide. These include a digital camera, seven picnic tables, several benches, a laptop computer and software, a desktop computer, an LED projector, an inflatable screen for outdoor viewing of videos, a subscription to the Meetup website, a scanner, printer ink, a water testing kit, an external computer drive, lumber for canoe dock at Griggstown, folding tables and twenty chairs for Bulls Island, development of a new park website and maintenance of the site at the rate of \$50 per month, and professional courses for the maintenance staff.
